

## Activities Allowed in Modified Phase 1

August 26, 2020

As of August 26, 2020, Chelan, Douglas, Benton, Franklin and Yakima counties are in a modified phase 1 per the [Safe Start plan](#). In addition to all phase 1 activities, the following activities are allowed in a modified phase 1 status starting on August 27, 2020.

<b>Activity Type</b>	<b>Activities Allowed</b>
<i>Outdoor group fitness classes</i>	<ul style="list-style-type: none"> <li>Classes are only allowed outdoors with five (not including the instructor) or fewer people. Physical distancing of at least 6 feet must be maintained among participants.</li> </ul>
<i>Social gatherings</i>	<ul style="list-style-type: none"> <li>Social gatherings are only allowed outdoors with 5 or fewer people outside the household per week. Physical distancing of at least 6 feet must be maintained.</li> </ul>
<i>Additional construction</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Manufacturing operations</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Real estate</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a> but guest occupancy limited to 25% of building occupancy and indoor services limited to 30 minutes per customer.</li> </ul>
<i>In-store retail (essential and non-essential)</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>. (Guest occupancy is limited to 30% of maximum building occupancy or lower as determined by the fire code.)</li> </ul>
<i>Personal services</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>, but occupancy limited to 25% of building occupancy, with the exception of one to one service in an enclosed room.</li> </ul>
<i>Professional services</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>, but occupancy limited to 25% of building occupancy, with the exception of one to one service in an enclosed room, and indoor services limited to 30 minutes per customers.</li> </ul>
<i>Professional photography</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Domestic services</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Pet grooming</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>, but occupancy limited to 25% of building occupancy.</li> </ul>
<i>Restaurants, taverns, breweries, wineries and distilleries</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a> but guest occupancy indoors is limited to 25% of maximum building occupancy as determined by the fire code. Outdoor seating is permitted at 50% capacity.</li> </ul>
<i>Staffed water recreation facilities</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">modified Phase 1 guidance</a>.</li> <li>Authorized operations include appointment-only lap swimming, one-on-one lessons, and small group classes (groups of 5 or less) at general use swimming pools only (e.g., athletic club pools and municipal pools) as defined in <a href="#">WAC 246-260-010(34)</a> and <a href="#">WAC 246-260-010(74)</a>. General use spas, general use wading pools, general use spray pools, limited use pools as defined in <a href="#">WAC 246-260</a>, and any recreational water contact facility regulated under <a href="#">WAC 246-262</a> are not included in this authorization at this time.</li> </ul>
<i>Religious services</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 religious guidance</a> but indoor services at a place of worship limited to 25% of room capacity or up to <b>50 people, whichever is less</b>, so long as six feet of physical distancing can be achieved between households.</li> </ul>
<i>Curbside library services</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Drive-in events, including movies and airshows</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a> for drive in theatres.</li> </ul>
<i>Team gymnastics, including training for USA Gymnastics</i>	<ul style="list-style-type: none"> <li>As outlined all <a href="#">Phase 2 guidance</a>.</li> </ul>
<i>Outdoor card rooms</i>	<ul style="list-style-type: none"> <li>As outlined in <a href="#">Phase 2 guidance</a> but the outdoor card room designated area of each facility is limited to <b>50 individuals</b>, (excluding organization staff), if proper physical distancing can be achieved.</li> </ul>
